ORDER

- 1. University vide paper read (1) above, had invited applications for Continuation of Provisional Affiliation for the academic year 2024-25 from the colleges for the courses affiliated to the University.
- 2. In response to the same, Principal, Vaidyarathnam P S Varier Ayurveda College, Kottakkal, vide paper read (2) above submitted their application with necessary documents and remitted required fee.
- 3. Subsequently, University carried out an inspection at the college to assess the facilities available for conducting UG (BAMS), PG Degree, PG Diploma courses with respect to the requested seats and the inspection commission submitted its report vide paper read (3) above.
- 4. Vide paper read (4) above, scrutiny committee verified the inspection reports and recommended to grant Continuation of Provisional Affiliation to Vaidyarathnam P S Varier Ayurveda College, Kottakkal for conducting courses for the AY 2024-25 with requested seats and the said recommendation was placed before the Governing Council meeting held on 29.05.2024 for consideration.
- 5. Vide decision read (6) above, the Governing Council resolved to grant Continuation of Provisional Affiliation to Vaidyarathnam P S Varier Ayurveda College, Kottakkal for conducting UG, PG Degree, PG Diploma courses for the academic year 2024-25, subject to the receipt of Letter of Permission from the NCISM, Govt. of India, Ministry of AYUSH as follows:-

- 6. Vide paper read (5) above, the Medical Assessment and Rating Board for the Indian System of Medicine (NCISM, Ministry of AYUSH, Govt. of India has granted conditional permission to Vaidyaratnam P. S.Varier Ayurveda Medical College, Kottakkal, for an intake capacity with 50 seats (63 including EWS) in UG (BAMS) course and 28 seats (35 seats including EWS) in 7 PG courses namely (i) Agada Tantra avum Vidhi Vaidyaka-04 seats (05 seats including EWS), (ii) Dravvaguna Vigyana -04 seats (05 seats including EWS), (iii) Kayachikitsa-Manovigyana avum Manas Rogator (07 seats including EWS), (vi) Shalya Tantra- 03 seats (04 seats including EWS), (v) Panchakarma 04 seats (05 seats including EWS), (vi) Ayurveda Samhita & Siddhanta 03 seats (04 seats including EWS) and 04 Ayurveda PG Diploma in (i) Manasik Swasthya- 02 seats (03 seats including EWS), (ii) Panchakarma 02 seats, (iii) Swastavritta and Yoga 02 seats and (iv) Dravyaguna Vigyan 02 seats (03 seats including EWS) for the academic session 2024-25 under section 28 of the NCISM Act 2020.
- 7. As per the paper read (7) above, Governing Council had decided that an affidavit incorporating a clause to the effect that " if GST is imposed on the affiliation and other services by the authorities concerned, such GST and other dues including penalty if any will have to be borne by the affiliated institutions" and the affidavit shall be submitted to the university by the affiliated colleges. The Principal, Vaidyaratnam P. S.Varier Ayurveda Medical College, Kottakkal, has not submitted the aforesaid affidavit to the university so far.
- 8. In the circumstances, orders are hereby issued granting **Conditional Continuation of Provisional Affiliation** to Vaidyaratnam P. S.Varier Ayurveda Medical College, Kottakkal, having permission from Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India for conducting UG and PG courses with the sanctioned intake mentioned against each shown in the above table for the academic year 2024-25. **The Conditional Continuation of Provisional Affiliation now granted will be confirmed only on submission of an affidavit by the college with respect to levying of GST in the prescribed format within 3 months of the date of this order.**
- 9. As per the clause 2(5)(ix)(16) of the amendment of the Ist Statute on the matter of Affiliation of Colleges, 'if conditional affiliation is granted, conditions to be fulfilled and the time fixed for fulfillment of the conditions shall be specified in the order of the Governing Council granting affiliation. If the conditions are not fulfilled by the end of the period fixed, the affiliation shall cease automatically. If the conditions are fulfilled, the Governing Council shall have the power to confirm the affiliation at the end of the period.'
- 10. The college shall stricly adhere to the following conditions detailed below:-
- i) The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting Phone: 0487-2207664, 2207642 Fax: 0487-2207616, 2207620 e-mail: keralahealthuniversity@gmail.com



permission to the college for conducting UG/PG Degree/PG Diploma courses in Ayurveda during 2024-25 vide letter read (5) above.

- ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- iii) In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- iv) Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for continuation of provisional affiliation for the ensuing years by remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- v) The college should remit balance annual administration fee fixed for UG/PG course for the academic year 2024-25, if applicable.
- vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.
