ORDER

University wide paper read (1) above, had invited applications for continuation of provisional affiliation for the academic year 2021-22 from colleges for courses affiliated to the University. Principal, Vaidyaratnam P S Varier Ayurveda College, Kottakkal, Malapuram vide paper read (2) above, had submitted application for the continuation of provisional affiliation for the year 2021-22.

On verification of the application, it is found that the college has submitted necessary documents and remitted requisite fee for continuation of provisional affiliation . Subsequently, University carried out inspection at the college to assess the available facilities for conducting the courses

The report submitted by inspection commission vide paper read(3) was scrutinised by Scrutiny committee in its meeting held on 03/09/2021 and recommended to grant Continuation of Provisional affiliation to Vaidyaratnam P S Varier Ayurveda College, Kottakkal, Malapuram .

The National Commission for Indian System Medicine , Ministry of AYUSH, Govt. of India has granted conditional permission to Vaidyaratnam P.S Varier Ayurveda College ,Kottakkal for conducting the following Ayurveda UG , PG and PG diploma courses for the academic year 2021-22 vide permission read 5th above.

The 66 th meeting of the Governing Council dated 16/11/2021 vide paper read(6) above has decided to grant continuation of provisional affiliation to Vaidyaratnam P.S Varier Ayurveda College ,Kottakkal for conducting courses for the academic year 2021-22, based on the recommendation of the Scrutiny Committee and the permission obtained from National Commission for Indian System Medicine , Ministry of AYUSH, Govt. of India .

In the above circumstances, sanction is hereby accorded to implement



the decision of the Governing Council and to grant Continuation of Provisional Affiliation to Vaidyaratnam P S Varier Ayurveda College, Kottakkal for conducting the following courses with an annual intake mentioned against each during the academic year 2021-22 subject to the conditions as detailed below:-

- (i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled
- (ii) In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- (iii) Affiliation granted is strictly provisional and only for the academic year 2021-22. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- (iv) The College should remit annual administration fee fixed for UG course for the academic year 2021-22
- (v) Admission to the next academic year shall be made only after obtaining prior permission from the University.
