Sir/Madam,

- To assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely Vaidyaratnam P.S. Varier Ayurvda College, Kottakkal Malappuram, Kerala (Inst. ID-AYU0110) inspection was conducted on 08.04.2025 & 09.04.2025 in hybrid mode as a part of annual visitation by the visitation team of Medical Asessment and Rating Board for Indian System of Medicine, NCISM to process the permission with intake capacity of 50 seats (63 Seats including EWS) in UG BAMS course, and 28 Seats (35 Seats including EWS) in 07 PG courses namely (i) Agad Tantra avum Vidhivaidyaka -04 Seats (05 Seats including EWS), (ii) Dravyaguna Vigyana-04 Seats (05 seats including EWS), (iii) Kayachikitsa-Manovigyana avum manas Roga -06 Seats (07 Seats including EWS), (iv) Shalya Tantra-03 Seats (04 Seats including EWS), (v) Panchakarma-04 Seats (05 seats including EWS), (vi) Swasthavritta-04 Seats (05 Seats including EWS), (vii) Ayurved Samhita & Siddhanta-03 Seats (04 Seats including EWS) under section 28 of NCISM Act, 2020.
- 2. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namelythe Minimum Essential Standards, Assessment and Rating for Undergraduate and Postgraduate Ayurveda colleges and Attached Teaching Hospitals Regulations, 2024 and Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda Regulations 2024", provisions under the NCISM Act, 2020 and relevant Regulations there under.
- 3. Further, the Board had issued a letters to the college vide ref no. 3/2025/MARB/General Matters Dated 05.05.2025 with regard to abolition of PG diploma courses regulation no. 3 (3) (c) of MESA&R PG Ayurveda Regulation 2024, to which the college had submitted their compliance.
- 4. On careful examination of the assessment report it is found that your college is not fulfilling the notified & approved criteria, due to the following shortcoming:
 - a. Non-teaching staff: -
 - Availability of Non-Teaching staff is $\frac{\text{Available}}{\text{Required}} \text{x} 100\% = \frac{24}{30} \text{x} 100\% = 80\%$.

The assessment report was duly placed in the 129th Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) convened on 27.06.2025 and Board observed that the college is not fulfilling the notified & requisite criteria for issuance of permission as per the concerned acts and regulations and the criteria in accordance with the Board's policy letters issued on 09.01.2025 & 20.01.2025 for issuance Permission with intake capacity of 50 seats (63 Seats including EWS) in UG (BAMS) course and for intake capacity of 32 Seats (40 Seats including EWS) in 07 PG courses namely (i) AgadTantra avum Vidhivaidyaka -04 Seats (05 Seats including EWS), (ii) Dravyaguna Vigyana-05 Seats (06 seats including EWS), (iii) Kayachikitsa-Manovigyana avum manas Roga -07 Seats (09 Seats including EWS), (iv) Shalya Tantra-03 Seats (04 Seats including EWS), (v) Panchakarma-05 Seats (06 seats including EWS), (vi) Swasthavritta-05 Seats (06 Seats including EWS), (vii) Ayurved Samhita & Siddhanta-03 Seats (04 Seats including EWS) under section 28 of NCISM Act, 2020, for the academic session 2025-26. Hence the Board decided to issue Permission after clarification from the college regarding the shortcomings observerd during the assessment.
- Further, an opportunity of clarification vide letter of even no. dated 09.07.2024 was issued to the college. In response of the same the college has submitted the clarification vide ref no. E3-76/2025/AVC dated: 15.07.2025. The submitted clarification was assessed and was found complying.
- 7. Hence, as per the decision of Board in the 129th Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) convened on 27.06.2025 after clarification the college is fulfilling the criteria as per the Board's policy letter dated 09.01.2025 & 20.01.2025 for
 - a) Extended Permission with an intake capacity of 50 seats (63 Seats including EWS) in UG BAMS course in accordance with Regulation 54 (2) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024, provision under section 28 of NCISM Act, 2020, for the academic session 2025-26.
 - b) Extended Permission with an intake capacity of 32 Seats (40 Seats including EWS) in 07 PG courses namely (i) AgadTantra avum Vidhivaidyaka -04 Seats (05 Seats including EWS), (ii) Dravyaguna Vigyana-05 Seats (06 seats including EWS), (iii) Kayachikitsa-Manovigyana avum manas Roga -07 Seats (09 Seats including EWS), (iv) Shalya Tantra-03 Seats (04 Seats including EWS), (v) Panchakarma-05 Seats (06 seats including EWS), (vi) Swasthavritta-05 Seats (06 Seats including EWS), (vii) Ayurved Samhita & Siddhanta-03 Seats (04 Seats including EWS) in accordance with Regulation 15(5) of NCISM (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulations 2024, as per the provision under section 28 of NCISM Act, 2020, for the academic session 2025-26.

"DECISION"

- 8. Therefore, Vaidyaratnam P.S. VarierAyurvda College, Kottakkal Malappuram, Kerala (Inst. ID-AYU0110) is hereby granted with:
 - a) Extended Permission with an intake capacity of 50 seats (63 Seats including EWS) in UG BAMS course in accordance with Regulation 54 (2) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024, provision under section 28 of NCISM Act, 2020, for the academic session 2025-26 and
 - b) Extended Permission with an intake capacity of 32 Seats (40 Seats including EWS) in 07 PG courses namely (i) AgadTantra avum Vidhivaidyaka -04 Seats (05 Seats including EWS), (ii) Dravyaguna Vigyana-05 Seats (06 seats including EWS), (iii) Kayachikitsa-Manovigyana avum manasRoga -07 Seats (09 Seats including EWS), (iv) Shalya Tantra-03 Seats (04 Seats including EWS), (v) Panchakarma-05 Seats (06 seats including EWS), (vi) Swasthavritta-05 Seats (06 Seats including EWS), (vii) Ayurved Samhita & Siddhanta-03 Seats (04 Seats including EWS) in accordance with Regulation 15(5) of NCISM (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulations 2024, as per the provision under section 28 of NCISM Act, 2020, for the academic session 2025-26.
- 9. The aforementioned Permission is issued under section 28 of NCISM Act, 2020 subject to the condition that following requirements shall be fulfilled:-

- I. It is informed that minimum 15% of undergraduate seats of the permitted intake capacity with 50 seats (63 seats including EWS) and minimum 15% of postgraduate seats of the permitted intake capacity with32 Seats (40 seats including EWS) in each 07 PG courses shall be treated as all India quota. The counseling for seats under all India quotashall be conducted by respective counseling authority as designated by Central Government for A.Y. 2025-26 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction for all India quota or the students admitted thereunder.
- 10. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
- 11. Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.
- 12. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 13. You are hereby instructed to comply with all the requirements of Aadhaar Enabled Biometric Attendance System as mentioned in the Implementation letters vide. ref. no. 3/2024/MARB/AEBAS & HMS. Dated 09.05.2024 & 06.09.2024 issued by the Board.
- 14. The following requirements must be fulfilled and the compliance report must reach the Board by 31st December, 2025 to be considered for the issuance of permission for the academic session 2026-2027:-
 - All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled.
 - ii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum essential standards, assessment and rating for undergraduateAyurveda colleges and attached teaching hospitals) Regulations, 2024.
 - iii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulations, 2024.
- 15. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college within the timeline as mentioned above to the President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2026-27.
